



## **\$1,000 HPI SUNSHINE MILLIONS HANDICAPPING CONTEST SATURDAY JANUARY 24<sup>th</sup> 2009**

Patrons at Hastings Racecourse, Fraser Downs Racetrack & Casino, the Racebooks at River Rock and Boulevard Casinos can win a \$1,000 deposit to their HPI Account simply by entering our FREE HPI Sunshine Millions Simulcast Handicapping Contest on Saturday, January 24, 2009.

### **Qualified Contestant and Entry**

- A qualified contestant ("Contestant") is someone who is a BC HPI Member. Employees of Great Canadian Gaming Corporation and its subsidiaries and affiliates (collectively, "GCGC") and the British Columbia Lottery Corporation ("BCLC"), as well as family and household members of same who reside at the same address are not eligible.
- A qualified entry ("Entry") is on an original GCGC entry form that must be completed by the Contestant in its entirety, must be legible and must be handed in to the HPI / Guest Service Centre at Hastings Racecourse, Fraser Downs Racetrack & Casino, the Racebooks at Boulevard Casino or River Rock Casino
- Contestant and Entry must meet all Contest Conditions as outlined below. Contestant and/or Entry not meeting Contest Conditions will be disqualified and prize will be forfeited.
- All qualified entrants must be 19 years or older.

### **Entry Ballots:**

- Entry ballots will ONLY be available to HPI Cardholders
- HPI Cardholders will receive their ballot from HPI / Guest Services, at Hastings Racecourse and Fraser Downs. Ballots will also be available at the Racebook at Boulevard Casino and the Racebook at River Rock.
- Entry Ballots will be made available on Friday January 23, 2009 at 10:00am until Saturday January 24, 2009 fifteen minutes prior to post time of the first Sunshine Millions Contest race.
- All ballots must be handed in to the HPI / Guest Service window by the start of the first Sunshine Millions Contest race.

### **Selections:**

- HPI Cardholders must select one entry for each of the eight Sunshine Millions races taking place at Santa Anita Park and Gulfstream Park.
- The winner will be decided based on a cumulative total of points.

### **Determining a Winner:**

- There will be one winner of \$1,000 from all ballots received from Hastings Racecourse, Fraser Downs, River Rock, and Boulevard Racebooks
- At the end of the day, the results are tallied for 1st, 2nd and 3rd in all eight races
- Points are allocated so that the winning horse in each of the eight races receives 5 points.
- Each second place finisher will receive 3 points.
- Third place finishers receive 1 point.
- At the end of the day, the results are tallied for 1st, 2nd and 3rd in all eight designated races and the entrant with the most points will be declared the winner. In the event of a tie the \$1,000 prize will go to the entrant with the most winners selected. If there is still a tie the prize money will be shared by the tying entrants.
- The official winner will be declared on Monday January 26<sup>th</sup> 2009.
